Councilor Eckstein thanked Councilor Walls for his service to the community,

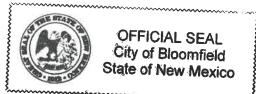
Councilor Walls mentioned that this was his last meeting and that it had been an honor and a privilege serving the community.
